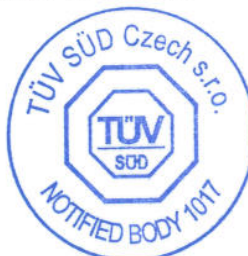

1. Conditions related to certificate validity period

The present certificate is valid for the period of ten years since the date of its issue, and can be issued again on request.

Changes and alteration variances of the pressure equipment other than these that have been certified within a particular design have to be disclosed to TÜV SÜD Czech without delay. Such a circumstance may make further certificate validity dependant on additional conformity evaluation.

Required service and assembly manuals shall be attached to each product.

Each product shall bear a clear producer or importer reference and its type name, in order to enable to find out the identity of certificated proposal with products that got afloat.

2. Rules of the certificate disposal:

The certificate can be used only as the certificate for particular design of products that are specified on the first page. This is also applied to the use within promotional, advertising and commercial materials.

This certificate can be copied only in whole. There is forbidden to change it, add anything into it or write out the certificate data.

Unauthorized or false use of the certificate can be subject to sanctions (§ 19 of the Act No. 22/1997 Coll., as amended).

The certificate cannot be used as the certificate related to design of products that were changed without the consent of TÜV SÜD Czech. Such a change influences the conformity of used normative documents and regulation.

The entitlement to use the certificate can be applied only for its owner and for the products and production facilities indicated herein. The owner of certificate cannot transfer it towards third persons, and third persons also cannot use it. Only TÜV SÜD Czech is entitled to transfer it towards third subject.

If there are no closer details, General conditions for products certification of up-to-date wording shall be applied.

This language version of the certificate is a translation of a Czech official version No. 06.412.662 issued on 24.01.2013, which is deemed the only one applicable in the event of legal disputes and was printed on 24.01.2013.
